Critical 'Loupe' Holes: Conflict Diamonds and Security Threats Arising from Kimberley Process Weaknesses

The diamond supply chain is transnational, highly complex, and a convenient target for international diamond trafficking, money laundering, terror financing, and organized crime. Maintaining integrity in the diamond supply chain is both a public policy and national security interest as critical security threats arise within the global supply chain, from human rights atrocities in diamond mines, to authenticity issues with domestic importation and verification.

This article assesses the effectiveness of the existing "soft law" framework of the Kimberley Process, role model nations, impoverished diamond-rich nations, and illicit actors in the diamond shadow economy.

Executive Privilege and Inspectors General — The Middle-Man

Because of the inspectors' general unique location in the executive branch, their congressionally mended structure, and their mandated reporting requirements, concerns over executive privilege claims for agency documents are a tense subject in terms of separation of powers.

While the Executive may have functional control over confidential information held by inspectors general, this article proposes that the Executive does have formal legal control over inspectors general and explores the assertion of executive privilege and the inspectors' general congressionally mandated oversight power.

Justice Jackson and Footnote Seventeen: Was Truman's Seizure in Youngstown Distinguishable from Roosevelt's Seizure of North American Aviation?

"The discordance between Justice Jackson's opinion in Youngstown and his actions as Attorney General under Franklin Roosevelt in 1941 have received far less attention. Namely, his failure to adequately distinguish President Truman's Seizure in Youngstown and President Roosevelt's seizure of North American Aviation in 1941. Ten years before Truman's actions, his predecessor, with the help of Attorney General Jackson, had done a remarkably similar act."





The Inherently Political Nature of the Foreign Agents Registration Act: A Statute in Need of Improvement

"Foreign Agents Registration Act (FARA) has a history of being unevenly enforced within different political climates—sometimes not being enforced at all—but today FARA criminal and civil prosecution is thriving, and we must ask ourselves how we got to where we are today and what the future of FARA enforcement will entail."
