***National Security Law Journal* Brings Former U.S. Attorney General Michael Mukasey to Mason Law Campus**

Speakers to examine NSA, wiretapping, and PRISM on Wednesday 3/26

ARLINGTON, VA — The *National Security Law Journal* at George Mason University School of Law recently announced that its spring symposium will feature a keynote address by former U.S. Attorney General **Michael Mukasey**, who will speak on the NSA, wiretapping, and the data mining program known as PRISM. The event will be held on the afternoon of Wednesday, March 26, 2014, on the Arlington Campus of George Mason University.

“Attorney General Mukasey held a critical role in the evolution of national security law post-9/11, and we are thrilled to bring him to Mason to discuss the legal implications of one of the most important issues in the field,” said Amy Shepard, Editor-in-Chief of the *Journal*. A debate between Professor **Robert Turner** of the University of Virginia School of Law and Professor **Stephen Vladeck** of American University’s Washington College of Law will follow Judge Mukasey’s keynote address. Professor **Jeremy Rabkin** will moderate the debate. “We think Vladeck and Turner’s academic perspective on national security law will complement Mukasey’s *in vivo* experience,” added Noah Oberlander, Executive Editor of the *Journal*. The debate will be co-sponsored by the Center for Infrastructure Protection and Homeland Security, the Federalist Society, and the Thomas More Society at George Mason University School of Law.

“This is an exciting time for the *National Security Law Journal*,” said Shepard. “We hope many students and practitioners will attend the symposium to hear from such an influential figure as Judge Mukasey.” The keynote address by Judge Mukasey will begin at 3:00pm, followed by the debate with Professors Vladeck and Turner at 4:00pm, and a post-event reception with a cash bar at 5:00pm.
